

# Ventress Memorial Library

## Board Meeting

April 26, 2017

Mr. Coyle called the meeting to order at 4:06PM.

1. Mr. Coyle made a motion to approve the March 17, 2017 minutes. Mr. Guimond approved and Mrs. White seconded and all approved.
2. **Director’s Report:**
  - A. Ms. Marcoux passed around pictures of the progression of the Library extension. Expected completion is mid-June. Ms. Marcoux went over the Grand opening itinerary. Trustee agreed that Saturday June 24<sup>th</sup> from 4-6 would be a good day and time. Inviting former trustees, Steve Carell & Steven Tyler.
